Introduction

Our position is that recycling, upcycling, and waste-to-energy, while beneficial, do not encompass the entirety of the circular economy. These practices merely represent an incremental improvement over the linear economy and they do not deliver the full benefits of sustainable, far-reaching climate actions necessary for a future-ready society.

1. The Misconception of Recycling Economy as Circular Economy

Recycling, upcycling, and waste-to-energy are often touted as pillars of the circular economy. However, focusing exclusively on these practices perpetuates a "Recycling Economy," which remains fundamentally linear. This approach deals with waste at the end of the product lifecycle, treating waste as an afterthought rather than realising its full potential.

The true essence of a circular economy lies in designing out waste and pollution from the outset. By asking industries to heavily invest in recycling and waste management infrastructures, which take decades to yield returns, we perpetuate the notion of waste and delay the adoption of genuine circular practices. This is misplaced attention. It diverts resources away from innovative circular solutions that businesses are ready to deploy and opportunities for greater value creation.

2. The Broader Scope of Circular Economy

The circular economy must be understood as more than just solid waste management and reducing waste flows to landfills. It encompasses how society accesses and benefits from goods and services in a way that is regenerative and sustainable. This paradigm shift moves beyond "doing less harm" to actively "doing more good."

Supporting a circular economy means supporting business models and societal structures that restore and regenerate. It involves rethinking how businesses generate profits sustainably and fosters a better livelihood for people. By aligning with natural systems, we can achieve better outcomes for current and future generations.

Constructive support and well-structured regulations are essential for fostering a conducive environment for circular business models. It is counterproductive to criticize businesses for "not doing enough" without clear guidance on how to progress towards greater circularity.

Our growing business community is ready to engage on multiple fronts to address and solve the challenges faced in implementing the circular economy. This collective commitment underscores our potential for significant impact and collaboration.
